

Starr County Marriage License Requirements:

- There is a 72 hour waiting period immediately following the date the license is issued.
- The marriage license expires 90 days after the issuing of the marriage license.
- Both applicants need to be present
- Blood tests are not required

The following may be used for proof of identity and age:

- Birth certificate
- Driver's License
- State ID
- Military ID
- Passport
- Certificate of Citizenship
- Resident Alien Card
- Border Crossing Card

Social security numbers are required

The following may be used for proof of social security numbers:

** Original social security card

*An original certified copy of the *divorce decree or Death certificate* if you have been previously married.

*All documents must be original or a certified copy of the original document

*We will not accept expired or mutilated documents

SB 1705: Underage Marriage License Applicants

A county clerk may not issue a marriage license if either applicant is under 18 years and has not presented a court order filed with this state that removes the disabilities of minority.

SB 1705 amends Section 2.009 of the Texas Family Code, so that a county clerk may not issue a license if either applicant is under 18 years of age and has not presented a court order granted by this state under TFC Chapter 31 removing the disabilities of minority of the applicant for general purpose; or, if the applicant is a nonresident minor, a certified copy of an order removing the disabilities of minority of the applicant for general purposes filed with this state under TFC 31.007

Effective September 1, 2017

Divorced Participants

There is a 30 day waiting period immediately following the date the Judge signs the divorce decree. If the Judge has waived the 30 day waiting period, the court order must be presented at the time of applying for the marriage license on the 31st day after a divorce. Former spouses may marry each other at any time.

Requisitos de la licencia de matrimonio del condado de Starr:

- o Hay un período de espera de 72 horas inmediatamente después de la fecha en que se emite la licencia.
- o la licencia de matrimonio expira 90 días después de la emisión de la licencia de matrimonio.
- o Ambos solicitantes deben estar presentes
- o No se requieren análisis de sangre

- o Acta de nacimiento
- o Licencia de Conducir
- o Id. de estado
- o Identificación militar
- o Pasaporte
- o Certificado de Ciudadanía
- o Tarjeta de Extranjero Residente
- o Tarjeta de cruce fronterizo
- Acta de divorcio o Acta de defunción para persona que previamente han sido casados.
- *Todos los documentos deben ser originales o una copia certificada del documento original
- *No aceptaremos documentos caducados o mutilados

Se requieren números de seguro social

Se puede usar lo siguiente como prueba de números de seguro social:

- *Tarjeta de seguro social original
